Wednesday, March 11, 2020**

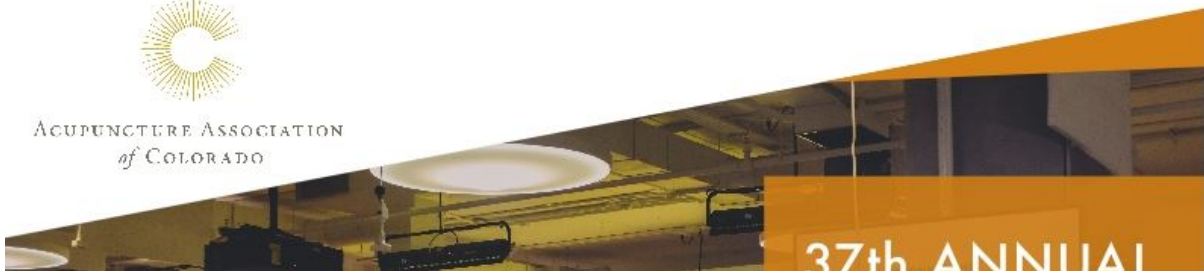

Medicare

Medicare is covering now covering acupuncture in specific instances. The following is from the American Acupuncture Council and does a thorough job of answering the FAQs:

There is no direct payment to an LAc at this time and Medicare will not register any LAc to the Medicare program. However, this unprecedented ruling does now include acupuncture under Medicare. But with the following protocols:

1. The LAc would have to be employed and work incident to an MD, PA or NP.
2. There is no direct payment to the LAc or Medicare registration but paid to the medical provider and the acupuncturist must be an employee.
3. It is limited to chronic lower back pain for 12 weeks or greater and up to 20 visits in a year (12 visits within 90 days and if it is effective up to an additional 8).

For the purpose of this decision, chronic low back pain (cLBP) is defined as:

- Lasting 12 weeks or longer;
 - nonspecific, in that, it has no identifiable systemic cause (i.e., not associated with metastatic, inflammatory, infectious, etc. disease);
 - not associated with surgery; and
 - not associated with pregnancy.
1. The AAC Insurance Information Network interprets this as a start and a study to determine the effectiveness of acupuncture and should lead to a positive outcome. This should lead to Medicare allowing full membership and direct claims from LAc providers just as the VA has done.
 2. This level of coverage was not expected as it was announced that there would be a “study” only so certainly the fast track bodes well for the future of acupuncture in the Medicare program.
 3. Acupuncture will be reimbursed in the range of \$40-50 per set depending on your region.

Legislative Update

Healthcare is of primary concern for the Polis Administration and the Opioid Crisis is a critical issue in that arena. We are closely following all healthcare related legislation and are directly involved in legislation that has come out of the Opioid and Other Addictive Substances Interim Committee.

On Tuesday, January 28th, 2020, Mark Van Otterloo represented the acupuncture profession and testified regarding the rulemaking process by DORA from HB 19-1174 regarding balance billing. He was joined by the associations current lobbyist Lara Lee Hullinghorst and CSTM student Maddie Bergner. The focus of HB 19-1174 was to reduce surprise billing when a patient is receiving care at an in-network facility with an out-of-network provider. The rulemaking process will still allow patients to be balance billed (at this point) so long as the patient is aware that the provider they are seeing is out-of-network. In either event, this is largely a rule that will effect hospital based practices more than private practice, though all acupuncturists will have a waiver outlined in the rule that

than private practice, though all acupuncturists will have a waiver outlined in the rule that patients will need to sign informing them of their rights. These waivers will be universal amongst healthcare providers which will create a Colorado standard for balance billing. The rulemaking will have its final hearing on February 21st, 2020. Your board, under the advisement of our lawyer Stuart Wilcox, has identified two areas where confusion may arise regarding the proposed rules. We submitted our comments both in writing and in person. We have attached our written comments for anyone interested in the specific response.
